The Village is working with the NYPA to replace all the street lights in the Village with LED lights. The PSEG Transmission project is continuing with vaults being installed on Dogwood Avenue. When the project is completed this summer, PSEG will completely repave Dogwood Avenue, Hempstead Avenue, and Broadway.
